Re Detroit letter to Bureau, 3/4/71 and Bureau airtel to Detroit, 2/25/71.

(U) In view of informant's application for position with USA's Office, Detroit, Michigan, which is being favorably considered presently by USA, Detroit, this informant is being discontinued as of this date.

For the information of the Bureau, informant is willing to testify in any matter of interest to the Government, should the Bureau and/or the Department wish his testimony. It is noted he has not been exposed as an informant; however, his assumption of employment with the Department as an AUSA should amount to the same thing as exposure through testimony.

Review of informant furnished by this informant does not identify any matters in which Department has expressed interest in his testimony. There are no identified SGE cases, in matters furnished by informant, which would require preparation of material for dissemination presently.

Administrative steps dictated by M of I, Section 107 "0" have been taken by Detroit regarding discontinuance of this informant. Since he has not to date been exposed, his identity will continue to be protected in material disseminated. He continues up to the present time to furnish information of value to the Bureau, all based on past associations and/or activities.

Bureau requests in referenced airtel what information may be furnished the Department regarding informant. Following is recommended:

KENNETH JOEL HABER, presently an applicant for position with the office of the United States Attorney, Detroit, Michigan, during the period 1965-1970, while a student at the University of Michigan, Ann Arbor, Michigan, was operated as an informant by this Bureau. In 1965, he initiated contact with the Bureau, furnishing information in a complaint of what he said he considered "treasonous activity" on the campus of the University of Michigan (UM). Based on his close personal association through employment with [Redacted]

[Redacted] of SDS at the UM, he continued to volunteer information to this Bureau. In efforts to be of further assistance to the Government, HABER voluntarily joined the SDS at the UM. He attended numerous national and regional meetings of the SDS, and in the period 1965-1970 was closely associated with the leadership of the SDS at the UM.

Information furnished by HABER to this Bureau has been independantly determined to have been completely reliable. Additionally, it is noted, he displayed considerable courage and inventiveness, personally, in securing information of this nature. He has maintained this relationship in complete confidence, and to date has not been disclosed as having maintained SDS and "New Left" associations in an effort to be of assistance to the Government.
